<ul style="list-style-type: none"><li><i>Demonstrate knowledge and understanding in the main field of study, including both broad knowledge of the field and a considerable degree of specialized knowledge in certain areas of the field as well as insight into current research and development work, and demonstrate specialized methodological knowledge in the main field of study.</i></li></ul>
<b><i>Competence and skills</i></b>
<ul style="list-style-type: none"><li><i>Demonstrate the ability to critically and systematically integrate knowledge and analyze, assess and deal with complex phenomena, issues and situations even with limited information.</i></li><li><i>Demonstrate the ability to identify and formulate issues critically, autonomously and creatively as well as to plan and, using appropriate methods, undertake advanced tasks within predetermined time frames and so contribute to the formation of knowledge as well as the ability to evaluate this work.</i></li><li><i>Demonstrate the ability in speech and writing both nationally and internationally to report clearly and discuss his or her conclusions and</i></li></ul>

- *Demonstrate the skills required for participation in research and development work or autonomous employment in some other qualified capacity.*

- *Governance.*
- *Health service delivery and workforce.*
- *Interprofessional collaboration.*
- *Models of health care financing and universal health coverage (UHC).*
- *Policy briefs.*
- *Ensuring equitable access to medical products and technology.*
