Detailed information about the Student UT Insurance, Terms and Conditions 2021-07-01;

Kammarkollegiet is a Swedish state authority. One of our assignments is to provide insurance solutions to other Swedish authorities, including universities in Sweden. We insure state property, buildings, employees, and students, to name a few.

The student is covered by insurance during the exchange period, throughout the semester, and the insurance also applies two weeks prior and two weeks after the exchange period.

### Medical and dental care cover and Reimbursement

The insurance covers necessary, reasonable, and certified costs for emergency or non-elective care. Kammarkollegiet defines emergency care as follows: care needed for an illness or accident that occurs during the stay abroad and care is needed as soon as possible, for example stomach ache or a fever. Including dental and mental care and also care through virtual channels.

For example, the insurance covers the care for a fractured bone as well as the rehabilitation after the fracture – with care from a physiotherapist or alike, inside or outside of the hospital.

It would cover examination, including for example X-ray, if the student finds a lump and find the need to check it up. We see this as emergency care since it is a new illness that the student didn't know about when they left Sweden.

The insurance covers emergency medical treatment for a person with a chronic illness, pre-existing condition, that deteriorates during their stay abroad. The insurance covers care for mental illness that outbreaks or grow worse abroad.

In the event of pregnancy, compensation is paid for expenses for emergency medical care abroad for the insured in connection with delivery, miscarriage, or other serious complications before the end of the 28th week of pregnancy (27+6). In such cases, compensation can be paid for medical care for both mother and child for more than 90 days

The cover includes prescription drugs, all athletic or other activities during school hours, as well as during free time.

There is no maximum amount regarding the insurance coverage for emergency or non-elective medical or mental health care. That includes Medical Evacuation and Repatriation. There is no deductible to this insurance.

If the student can't pay for the care, they can ask for an invoice from the care provider, in the student's name. The student can then send the invoice directly to Kammarkollegiet with a claim form and *Kammarkollegiet will cover the cost of the care and pay the invoice* 



directly to the care provider. The cost is fully covered by the insurance, no co-insurance.

The student can visit any care provider in the U.S. In case of serious illness, hospital admission, need for transport home or other active assistance in the event of injury abroad, the student can contact Falck Global Assistance.

#### Assistance

Kammarkollegiet cooperate with Falck Global Assistance in case of emergency for our policyholders. Falck Global Assistance cooperate in turn with United healthcare Global when assistance is needed in the US or Canada.

As this specific client is not officially enrolled in UHC, Falck Global Assistance will assist through their local office, Falck Global Assistance US, in issuing the necessary paperwork (Verification of benefits) when this client is in need of medical attention. The medical provider will then receive all the necessary details to proceed with the billing through UHC.
